Product Description

Immortalized RFP-Expressing Mouse Primary Cardiac Fibroblasts from Cell Biologics are isolated from the heart tissues of pathogen-free laboratory C57BL/6 mice and grown in gelatin pre-coated tissue culture flasks with Cell Biologics' Complete Growth Medium. Cells at passage 2-3 are harvested from flasks and cryo-preserved in vials. Each vial contains 0.5×10^6 cells per ml and is delivered frozen. Immortalized RFP-Expressing Mouse Primary Cardiac Fibroblasts are characterized by their spindle morphology and immunofluorescence staining with anti-FSP1/S100A4 (Millipore USA) antibodies. These cells are negative for bacteria, yeast, fungi, and mycoplasma. Cells can be expanded for more than 10 passages at a split ratio of 1:2 under the cell culture conditions specified by Cell Biologics. Repeated freezing and thawing of cells is not recommended.

Immortalized cells from Cell Biologics are derived from primary cells expressing RFP. These primary cells are immortalized by over-expression of the large T-antigen of the simian virus (SV40) or human telomerase reverse transcriptase (hTERT).

The green fluorescent protein (RFP) gives rise to very bright green fluorescence when exposed to blue light. Cell Biologics generates various RFP-expressing stable cells RFP-expressing cells are developed through transducing RFP-lentiviral particles.

Storage

Cryopreserved cells are shipped with dry ice overnight. Upon arrival, transfer frozen cells to liquid nitrogen (-180°C) immediately until ready for use. Live cell shipment is also available on request. Primary cells can never be kept at -20°C or -80°C freezer.
