

## RFP-Expressing Mouse Primary Coronary Artery Endothelial Cells

### Product Description

RFP-Expressing Mouse Primary Coronary Artery Endothelial Cells from Cell Biologics are isolated from the coronary artery of pathogen-free laboratory C57BL/6 mice and grown in gelatin pre-coated tissue culture flask with Cell Biologics' Complete Growth Medium. Cells at passage 3 are harvested from flasks and cryo-preserved in vials. Each vial contains  $0.5 \times 10^6$  cells per ml and is delivered frozen. RFP-Expressing Mouse Primary Coronary Artery Endothelial Cells are characterized by immunofluorescence staining with antibodies of VE-cadherin (CD144, VE-cadherin Antibody, C-19, sc6458, Santa Cruz), AF1002 (R&D System) or CD31/PECAM-1 (Catalog No. 553370, BD). These cells are negative for bacteria, yeast, fungi, and mycoplasma and can be expanded for 3-5 passages at a split ratio of 1:2 under the cell culture conditions specified by Cell Biologics. Repeated freezing and thawing of cells are not recommended.

Red Fluorescent Protein (RFP), a mutant form of green fluorescent protein, gives rise to very bright red fluorescence when exposed to yellow-green light. Cell Biologics generates various RFP-expressing stable cells, including endothelial cells, epithelial cells and so forth. RFP-expressing cells are developed through transducing RFP-lentiviral particles.

### Storage

Cryopreserved cells are shipped with dry ice overnight. Upon arrival, transfer frozen cells to liquid nitrogen ( $-180^{\circ}\text{C}$ ) immediately until ready for use. Live cell shipment is also available on request. Primary cells can never be kept at  $-20^{\circ}\text{C}$  or  $-80^{\circ}\text{C}$  freezer.
