Product Description

Immortalized GFP-Expressing Cynomolgus Monkey Primary Dermal Fibroblasts from Cell Biologics are isolated from cynomolgus monkey skin tissue and grown in gelatin pre-coated tissue culture flasks with Cell Biologics' Complete Growth Medium. Cells at passage 2-3 are harvested from flasks and cryo-preserved in vials. Each vial contains 0.5×10^6 cells per ml and is delivered frozen. Immortalized GFP-Expressing Cynomolgus Monkey Primary Dermal Fibroblasts are characterized by their spindle morphology and immunofluorescence staining with anti-fibronectin antibodies. These cells are negative for bacteria, yeast, fungi, mycoplasma, HIV-1, hepatitis B and hepatitis C. Cells can be expanded for more than 10 passages at a split ratio of 1:2 under the cell culture conditions specified by Cell Biologics. Repeated freezing and thawing of cells are not recommended.

Immortalized cells from Cell Biologics are derived from primary cells with extended life span. The primary cells are immortalized by over-expression of the large T-antigen of the simian virus (SV40) or human telomerase reverse transcriptase (hTERT).

The green fluorescent protein (GFP) gives rise to very bright green fluorescence when exposed to blue light. Cell Biologics generates various GFP-expressing stable cells. GFP-expressing cells are developed through transducing GFP-lentiviral particles.

Storage

Cryopreserved cells are shipped with dry ice overnight. Upon arrival, transfer frozen cells to liquid nitrogen (-180°C) immediately until ready for use. Live cell shipment is also available on request. Primary cells can never be kept at -20°C or -80°C freezer.
