

## Luciferase-Expressing Rabbit Primary Epidermal Keratinocytes

### Product Description

Luciferase-Expressing Rabbit Primary Epidermal Keratinocytes from Cell Biologics are isolated from the skin tissue of New Zealand white rabbits and grown in gelatin pre-coated tissue culture flasks with Cell Biologics' Complete Growth Medium. Cells at passage 3 are harvested from flasks and cryo-preserved in vials. Each vial contains  $0.5 \times 10^6$  cells per ml and is delivered frozen. Luciferase-Expressing Rabbit Primary Epidermal Keratinocytes are characterized by immunofluorescent staining with ZO-1 antibody. These cells are negative for bacteria, yeast, fungi, and mycoplasma and can be expanded for 3-5 passages at a split ratio of 1:2 under the cell culture conditions specified by Cell Biologics. Repeated freezing and thawing of cells are not recommended.

Luciferase, distinct from GFP/RFP photoprotein, is widely used in bioluminescence. Cell Biologics generates various Firefly luciferase-expressing stable cells, including endothelial cells, epithelial cells and so forth. Firefly luciferase-expressing cells are developed through transducing Firefly luciferase-lentiviral particles.

### Storage

Cryopreserved cells are shipped with dry ice overnight. Upon arrival, transfer frozen cells to liquid nitrogen ( $-180^{\circ}\text{C}$ ) immediately until ready for use. Live cell shipment is also available on request. Primary cells can never be kept at  $-20^{\circ}\text{C}$  or  $-80^{\circ}\text{C}$  freezer.
