

Immortalized RFP-Expressing Porcine Primary Vein Fibroblasts

Product Description

Immortalized RFP-Expressing Porcine Primary Vein Fibroblasts from Cell Biologics are isolated from the vein tissue of American Landrace pigs and grown in gelatin pre-coated tissue culture flasks with Cell Biologics' Complete Growth Medium. Cells at passage 2-3 are harvested from flasks and cryo-preserved in vials. Each vial contains 0.5×10^6 cells per ml and is delivered frozen. Immortalized RFP-Expressing Porcine Primary Vein Fibroblasts are spindle-shaped and characterized by immunofluorescence with anti-fibronectin antibodies. These cells are negative for bacteria, yeast, fungi, and mycoplasma. Cells can be expanded for more than 10 passages at a split ratio of 1:2 under the cell culture conditions specified by Cell Biologics. Repeated freezing and thawing of cells are not recommended.

Immortalized cells from Cell Biologics are derived from primary cells with extended life span. The primary cells are immortalized by over-expression of the large T-antigen of the simian virus (SV40) or human telomerase reverse transcriptase (hTERT).

Red Fluorescent Protein (RFP), a mutant form of green fluorescent protein, gives rise to very bright red fluorescence when exposed to yellow-green light. Cell Biologics generates various RFP-expressing stable cells. RFP-expressing cells are developed through transducing RFP-lentiviral particles.

Storage

Cryopreserved cells are shipped with dry ice overnight. Upon arrival, transfer frozen cells to liquid nitrogen (-180°C) immediately until ready for use. Live cell shipment is also available on request. Primary cells can never be kept at -20°C or -80°C freezer.
